



### PUBLIC NOTICE ON TIME OF DAY TARIFF

This Public Notice is prepared by the Commission for seeking comments/suggestions from various stakeholders regarding revision of Time of Day (ToD) Tariff for FY 2018-19 in the area of National Capital Territory of Delhi.

1. The Commission had notified Business Plan Regulations, 2017 on 31/08/2017 for the Control Period for FY 2017-18 to FY 2019-20.
2. As per Regulation 34 of the said Regulations, the Commission has to specify the time slots for Time of Day (ToD) Tariff through separate Order. The relevant Regulation is as follows:

#### ***“34. Time Slots for Time of Day (ToD) Tariff***

*The Commission may, in terms of the Regulation 133 & 153 of the DERC (Terms and Conditions for Determination of Tariff) Regulations, 2017 specify Time Slots for Time of Day (ToD) Tariff through separate Order.”*

3. The Distribution Licensees BRPL, BYPL and TPDDL has submitted their proposal for review of Time of Day Tariff for FY 2018-19 is as follows:

- Further, the Commission has also analyzed the power availability from long term sources and the demand of the respective Distribution Licensees to determine the Time slots for Peak and Off Peak period based on the data of availability and demand submitted by SLDC and respective DISCOMs.
- The existing ToD Slots and consumer's applicability for all DISCOMs is as follows:

Months	Existing Peak Slots	Existing Off-Peak Slots
May - September	1300 Hrs – 1700 Hrs and 2100 Hrs-2400 Hrs	0300-0900 Hrs

- Mandatory for Sanctioned load/MDI > 25kW /27kVA (other than Domestic) and
- Optional for 11kW /12kVA < Sanctioned load/MDI < 25kW /27kVA (other than Domestic)

- The proposed ToD slots and applicability are as follows:

- Mandatory for all consumers having three phase (3 $\phi$ ) connections other than Domestic.
- Optional for all three phase (3 $\phi$ ) connections under Domestic category.
- Existing Surcharge & Rebate of 20% may be continued.
- The re-programming/meter replacement cost for mandatory three phase (3 $\phi$ ) connections may be considered in ARR which will subsidize the Short Term Power Purchase cost in Peak period and Loss on account of Sale of Surplus Power in Off-peak Period. However, the optional consumers have to bear re-programming/meter replacement cost.

- In accordance with the provisions of DERC Comprehensive Conduct of Business Regulations 2001 and Business Plan Regulations, 2017 comments/suggestions are invited from the consumers & other stakeholders on the above proposal.
