ORDER

(Date of Order: 29/04/2022)

- The Commission vide its Order dated 13/04/2022 in Petition Nos. 22 & 23 of 2022 directed TPDDL to "rediscover the prices either directly at DEEP or through Trader other than related party i.e. "TPTCL"."
- In this regard, TPDDL vide its representations dated 27/04/2022 and 29/04/2022 has submitted that the prices rediscovered at DEEP-Portal is as follows:

3. From above details, it is observed that current price discovery is higher than the earlier price discovery of TPDDL. TPDDL has submitted that the price bid discovery stipulated in Orders dated 13/04/2022 is valid till 1/05/2022 and 4/05/2022 for Petition No. 22 and 23 of 2022 respectively. Considering the current market prices at an abnormal high rates and prevailing power crisis, the Commission approves the lower price discovered by TPDDL earlier mentioned in Order dated 13/04/2022 in Petition Nos. 22 & 23 of 2022 for Delivery Period till 31/07/2022.
