ORDER

(Date of Order: 09.09.2020)

1. The instant Petition has been filed by BSES Rajdhani Power Ltd (BYPL) for Recovery of Power Purchase Cost Adjustment Charges (PPAC) for April – June '19 of FY 2019-20 in accordance with Section 62 (2) of the Electricity Act, 2003 read with Regulation 134 of the DERC (Terms and conditions for determination of Tariff) Regulations, 2017 and Regulation 30 of the DERC (Business Plan) Regulations, 2017.
2. Petitioner's submission:
 - i. Based on the audited accounts and records for the period April' 2019 to June' 2019 of FY 2019-20, the Petitioner has calculated the proposed PPAC percentage in line with the PPAC methodology specified by the Commission and it sums up to 5.85%. The Petitioner has levied PPAC of 4.50% pertaining to the period from April 19 to June 19 from the next billing cycle, i.e. for next three months with effect from 13th August, 2019.
 - ii. Further, the instant Petition has been filed for seeking permission of this Commission to levy differential PPAC claim of 1.35% i.e. (5.85 %-4.5%) on the consumers of the Petitioner.
3. Commission's Analysis:
 - i. The Figures and Formula as submitted by the Petitioner have been examined on the basis of Audited Power Purchase Certificate and actual bills submitted by the Petitioner. On scrutiny, it is observed that the Petitioner did not consider the normative rebate to be reduced from power purchase cost and transmission cost.

- ii. PPAC for April' 2019 to June' 2019 has been computed as per figure and formula as indicated in the following table:

- iii. PPAC for the Quarter from April' 2019 to June' 2019 for FY 2019-20 in respect of the Petitioner BRPL calculated as per the PPAC formula is 5.76%.
- iv. In view of the above, the Petitioner has become entitled for differential PPAC of 1.26% for the Quarter from April, 2019 to June, 2019. However, the aforesaid differential PPAC has already been subsumed in the Aggregate Revenue Requirement (ARR) of the Petitioner for FY 2020-21 vide Tariff Order dated 28.08.2020. No further order is required in this regard.
4. Accordingly, the Petition is disposed of.
