**Sub.: - Investigation Under Section 128 of Electricity Act, in respect of Load Shedding for the month of June 2009 in BSES Rajdhani Power Limited (BRPL) area of Delhi.**

In exercise of power conferred under Section 128 of Electricity Act, 2003, the Commission authorizes/appoints a Committee for investigation into load shedding for the month of June 2009 in BSES Rajdhani Power Limited area in Delhi. The Commission assigns this task for Security Audit of SCADA System of BSES Rajdhani Power Limited and verification of load shedding data from SCADA system with their MIS System maintained separately for the month of June, 2009 to the Committee consisting of the following:-

- (ii) Smt. Ratnaboli Dinda, Technical Director, NIC – Member
- (iii) Sh. Ravi Kumar, Pr. System Analyst, NIC – Member

- (v) Sh. K K Verma, Jt Director (Engg), DERC – Member Secretary
- (vi) Smt. Vaishali Rana ,Dy Director (IT), DERC – Member

2. The scope of work of the Committee shall be as under:-

- (i) Verification of data submitted by BSES Rajdhani Power Limited with data available on SCADA System of BSES Rajdhani Power Limited at Balaji Estate related to load shedding for the month of June 2009 so as to examine the correctness and appropriateness of data submitted by them to DERC.
- (ii) Verification of MIS data so as to examine the correctness and appropriateness of data manually fed by BSES Rajdhani Power Limited in their MIS system.
- (iii) Verification of transaction logs, archives logs, system logs and application logs of the SCADA system to ascertain whether any interference with data is recorded.
- (iv) Security Audit of software of SCADA System of BSES Rajdhani Power Limited.
- (v) To ascertain the actual quantum of load shedding carried out by BSES Rajdhani Power Limited in the month of June, 2009.

3. The Committee may, if required, co-opt any expert for the job at the expense of the Commission with the approval of the Secretary, DERC. The Committee shall submit report alongwith its findings and recommendations to the Commission within one month from the date of its constitution.

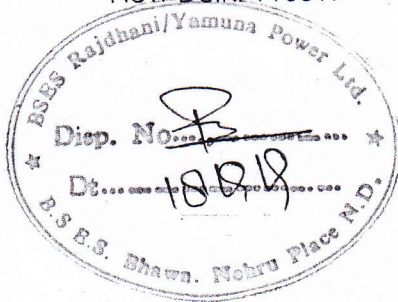


