3 To immediately stop further accumulation of Revenue Gap, a tariff correction is required primarily to cover the difference between Average Power Purchase Cost of ₹ 2.45 per unit assumed and factored in the current Tariffs as against projected Average Power Purchase Rate ₹ 5.10 per unit for FY 2011-12.

4 Regarding the recovery of accumulated Revenue Gap of ₹ 2553.02 crores upto 31.03.2011, a suitable amortization plan may have to be worked out.

6 **Proposal for implementation of periodic Power Purchase Price Adjustment mechanism:**
At present, due to the methodology of true up of power purchase costs on the basis of actual audit accounts, it takes almost two years before the recovery of legitimate power purchase costs while DISCOMs has to make payments to power suppliers on a monthly basis. The Commission is requested to institute a mechanism for pass-through of variations in power purchase cost to consumers on a regular basis (at monthly/quarterly intervals).

7 **Certain tariff rationalization measures are also proposed, as described in brief below:**

- Enhancement of limit for cash payment of energy bills by consumers
- Applicability of Tariff with load > 100 kW for Residential uses.
- kVah billing for Non-Domestic consumers having load < 10 kW.
- Introduction of time differential tariffs for consumers with load > 10 kW for Demand side management
- Uniform Fixed Charges upto sanctioned load of 5kW

- (b) Applicability of tariff with load above 100kW for residential use: There should be a different treatment tariff for individuals with load above 100kW for residential use; like it is for other categories e.g. Non-Domestic, Industrial etc. with load above 100kW.
- (c) Uniform fixed charges till the load of 5 kW: The majority of Domestic consumers have a connected load greater than 2 kW although their sanctioned load less than 2 kW. This gives undue advantage to consumers who have not increased their declared load to the actual connected load, while consumers of other billed load are paying the fixed charges. To avoid this, the slab-based fixed charges be rationalized.
- (d) kWh billing for industrial and non-domestic consumers with MDI greater than 10 kW: For industrial and non-domestic consumers with MDI greater than 10 kW, it should be entitled to charging kWh tariff since it encourages consumers to improve their power factor which eventually helps the system by less loading and reduction in losses.
- (e) Introduction of time differential tariffs for Consumers with Load > 10 kW for demand side management: Time Differential Tariffs would result in smoothening of demand curve which ultimately results in savings for the consumers by way of lower power purchase cost.
- (f) Proposal for implementation of Automatic Power Purchase Price Adjustment mechanism: At present, due to the methodology of true-up of power purchase costs on the basis of actual audit accounts, it takes two years before the recovery of legitimate power purchase costs for which distribution licensees have to make payments to power suppliers on an immediate basis. Therefore, a mechanism for pass-through of variations in power purchase cost to consumers on a regular basis (at quarterly intervals) is required.
- (g) Reduction in slabs for Domestic category: To simplify the tariff structure and to reflect the true cost-of-service to the Domestic consumer category, only two slabs be retained for energy charges. This would reduce the amount of cross-subsidy that is currently being provided to the Domestic category by the Industrial category (since the Domestic category tariff is lower than the actual cost of supply to this category). The two slabs proposed are:
 - (i) 0-200 units per month; and
 - (ii) Above 200 units per month (with the rate of energy charges being higher for this slab)

- i) For the year 2010-11, a large quantum of additional capacity with benefits for the National Capital Territory of Delhi was expected to be commissioned during the financial year, primarily from projects which were targeted to be commissioned prior to the Commonwealth Games.
- ii) The projection had considered a total power availability of 4526 MW during the FY 2010-11. Out of this 1935 MW alone was on account of new power stations which were expected to be commissioned during FY 2010-11, thereby leading to an estimated additional energy of about 20811 MUs. This additional power was estimated considering the dates of commissioning of new power plants as per information available from the website of the Central Electricity Authority (CEA) and other sources, although delays in commissioning appeared inevitable even at that time. A substantial part of this additional energy was expected to be surplus after meeting the requirements of Delhi utilities.
- iii) It was assumed that the surplus power will be sold at an average rate of Rs.5.75 per KWh against the average rate of about Rs. 3.25/KWh at which power was expected to be purchased by the distribution utilities.

Factual points of Actual Availability of Power

In this context, it is appropriate to clarify the factual position based on information available in the Commission at the present time.

- i) As expected, there have been delays in commissioning of the new power plants as detailed below:
- a. In case of DVC power plants, the Consultant considered the PPAs signed between DVC and Delhi utilities for supply of power, going upto 2500 MW in April, 2011 for future projects, namely, Chandrapur U# 7,8, Mejia TPS Ph-II, Maithon TPS, Koderma TPS and Durgapur TPS.

Hence as against the initial estimate of over 21,000 units being surplus, actual surplus units were only about 5800. Even these surplus units could not generate any monetary surplus for the reasons given below:

Reasons for reduction in Sale Rate of Surplus Power

- iii) The Central Electricity Regulatory Commission had in January, 2010 proposed change in the scheme of Unscheduled Interchange (UI). The revised Indian Electricity Grid Code, proposed to be implemented from the April 1, 2010 (draft of which was available months earlier) also stipulated that the operating frequency benchmark would be raised to 49.5 Hz from the then existing level of 49.2 Hz. Thus, the penal rate of Rs.12.22 / Kwh would be applicable for overdrawals below 49.5 Hz. and it was expected that the utilities in the country would refrain from overdrawing at a frequency below 49.5 Hz.
- iv) As expected, there was a significant reduction in the overdrawals by the distribution utilities on account of the penal rates applicable for overdrawals

below 49.5 Hz. following the introduction of the new regime of Unscheduled Interchange (UI) vide CERC Order dated 28th April, 2010 (effective 3rd May, 2010). This resulted in drastic reduction in the average UI rates as well as the rates for power sold on the power exchanges. The month-wise average rates for UI and the rates on the power exchanges during the period preceding the new Order of CERC and in the months following this Order is given in Table 3 below:-

- v) It would be seen from the above that the assumption regarding the premium at which the surplus power would be sold did not remain valid and the entire projected surplus did not materialise. Neither was the surplus power assumed in the calculation of the surplus available nor there was a premium on the sale of surplus power.
- vi) The future implication of the new regime would be that even after the commissioning of the new generating capacity from 2011-12 onwards, it may not be possible to generate a surplus from a sale of surplus power because there is now hardly any differential between the rates of power purchase and the rates at which the surplus power can be sold. In fact, there are times when

the rates for sale of surplus power are lower than the incremental rates for power purchase.

It would thus be seen that the assumptions on which the surplus of Rs. 3,577 Cr. was based no longer hold good.

Enhanced Cost of Power Purchase

Another factor which has a bearing on the tariff determination is the cost of power purchase incurred by the distribution utilities. When compared with the assumptions made while fixing the tariff for FY 2009-10, there has been a significant increase in the cost of power purchase which is partly attributable to the directions issued by this Commission vide letter No. F. 17(47)/Engg./DERC/2009-10/C.F. No. 2147/2956, dated 21.10.2009, wherein the Commission had directed the distribution utilities to limit the load shedding in their respective areas of supply to less than 1% of the total demand, failing which they would be penalised @Rs.2.50/Kwh for every unit of load shed.

Based on the audited accounts of the DISCOMs, the Commission, in its advice dated 15.12.2010 to the GNCTD under Section 86(2)(iv) of the Electricity Act, 2003, had observed that there has been a very considerable increase in power purchase costs incurred by the distribution licensees during FY 2009-10 and FY 2010-11. The power purchase cost which normally does not exceed 80% of the revenue from retail sale of electricity has increased much beyond this level. Table-4 of the advice which summarizes the percentage of power purchase cost vs. total revenue billed is reproduced below:-

The utilities are, therefore, not generating revenue even to make payments for the purchase of power, leave alone other expenses. Thus, the purported surplus of Rs. 3577 crore never materialized and the net result of operation during 10-11 was a net shortfall in revenue vs. operating cost.

It may also be noted that Government of NCT of Delhi had requisitioned the services of SBI Capital Markets Ltd. to examine the audited accounts of the distribution utilities for FY 2007-08, 2008-09 and 2009-10 and provide a financial analysis of the same in the light of claims made by the distribution utilities regarding their poor financial health.

The Report concludes that the financial analysis contained in the Report amply proves that the distribution utilities had not been able to pass on the increase/decrease in operating expenses (primarily power purchase costs) to the consumers in the same year. The liquidity position was precarious which is evident from the low current ratio and acid test ratio. Despite making book profits during 2009-10, the NOPAT (net operating profit after taxes) and EVA (economic value addition) were negative due to adjustments relating to review gaps to bring the EVA closer to cash flows.
