### **ORDER**

(Date of Order: 24.09.2015)

M/s. BSES Yamuna Power Ltd. (BYPL) has filed a Tariff Petition for approval of Truing up of Expenses up to FY 2013-14, Review & Provisional True up for FY 2014-15, and Aggregate Revenue Requirement (ARR) for Distribution (Wheeling & Retail Supply) Business for FY 2015-16, which was admitted by the Commission vide Order dated 11.02.2015. Executive summary along with the Petition were uploaded on the website of the Commission and also widely publicised through advertisement in newspapers. In pursuance of the advertisement, some of the stakeholders have furnished comments and suggestions, which were replied to by the Petitioner. The comments and suggestions of the stakeholders and the arguments advanced by the Petitioner and the submissions made during the public hearing held on 04.08.2015 have been taken note of.

After having considered the above, the Commission in exercise of the power vested in it by the Electricity Act, 2003 and Delhi Electricity Regulatory Commission (Terms and Conditions for Determination of Wheeling Tariff and Retail Supply Tariff) Regulations, 2011, hereby approves the enclosed Tariff Schedule, which shall be an integral part of the detailed Tariff Order to be issued by the Commission shortly.

The Petitioner shall take immediate steps to implement the said Order, so as to make the revised tariffs applicable from 01.10.2015.

This Tariff Schedule/Order shall remain in force till replaced by a subsequent Tariff Order and/or is amended, reviewed or modified, in accordance with the provisions of the Electricity Act, 2003 and the Regulations made thereunder.
