Record of Proceedings

(Date of Hearing: 27.03.2023)

1. Heard Officers of the Commission and Mr. Amit Kapur alongwith Mr. Buddy A. Ranganadhan for BSES Yamuna Power Ltd and BSES Rajdhani Power Limited. The Officers of the Commission have presented a detailed analysis and observations on the comparison submitted by BSES. The list of officers present from both the sides is at Annexure 'A'.
2. Mr. Amit Kapur, Counsel for the BSES submitted that with respect to items under A1.1 & A1.2 (Para 43 of the Compliance Order in Hon'ble Supreme Court Order dated 15.12.2022), they would like to further understand the details presented by the officers of the Commission. In this regard he has requested that a meeting may be conducted with the Officers of the Commission alongwith the Officials of the BSES for understanding the observations.
3. Mr. Kapur further submitted that in respect of details presented against Section A2 & Section A3 (Para 43 of the Compliance Order in Hon'ble Supreme Court Order dated 15.12.2022), the presentation does not cover as to which specific

aspects/items are comparable and which are not and if the details of non-comparable items are shared by the Commission then BSES will be able to file a Written Note regarding the same. He submitted that Commission may share the details of items not found comparable and sought two week's time to file their comments on the same for final decision by the Commission.

4. In view of above, the request of the Counsel of the BSES is considered and it is directed as follows :

- i. that the Officers of the BSES may sit along with the Officers of the Commission on 31.03.2023 at 3:00 PM in the Office of DERC and the details as requested for, with respect to A1.1 & A1.2 above, be shared with them.
- ii. that the Officers of the Commission to forward the details of non-comparable items with respect to A2 & A3 by Monday, i.e. 03rd April '23 and BSES to submit its comments by 17th April '23 to the Commission, as requested, for final disposal by the Commission for compliance.
