ORDER

(Date of Order: 31/03/2023)

- 1) The Commission is in receipt of applications from BRPL dated 27/03/2023 and 28/03/2023 wherein it has been brought to the notice that Northern Regional Power Committee (NRPC) has reallocated 173 MW of Power in Apr'23 & May'23 and 75 MW in Jun'23 to the State of Delhi based on BRPL request dtd. 16/03/2023 to MoP, GoI through Dept. of Power, GoNCTD for temporary re-allocation of upto 200 MW from Un-Allocated Pool of Power to meet the Peak Demand on account of Summer and G20 summit. The said Reallocation of Power is from ISGS Northern Region Generating Stations.
- 2) It is noticed by the Commission that during Summer Preparedness meeting conducted by the Commission on 3/3/2023, Delhi-SLDC anticipated Surplus (-)/ Shortage (-) for Delhi DISCOMs as follows:

- 3) Based on the inquiry from BRPL about expected Tariff from the said Reallocation by NRPC, BRPL vide it's letter dtd. 28/03/2023 has submitted that 76 MW out of 173 MW i.e., 44% is from Hydro sources and the tentative Tariff from 173 MW of Power is in the range of Rs. 2.04/kWh to 6.05 /kWh as determined by CERC which is competitive w.r.t. prevailing Short Term Prices varying in the range of Rs. 10/kWh to Rs. 15/kWh.
- 4) The Commission, in view of Regulation 121(4) of the *DERC (Terms and Conditions for Determination of Tariff) Regulations, 2017*, considering major shortfall of Power in BRPL in up-coming Summer Season (as tabulated above), G-20 Summit & area of strategic importance catered by NDMC, allocates the Power received from Unallocated quota of Central Generating Stations of Northern Region from 1/04/2023 to 30/06/2023 vide NRPC Order No. NRPC/OPR/103/02/2022/3256-3283 dtd. 23/03/2023, as follows:
