## **ORDER**

Date of Hearing: 28.02.2012  
(Date of Order: 12.03.2012)

1. The instant complaint has been filed by Sh. Daljit against the Respondent company under section 142 of the Electricity Act, 2003 for violation of Regulations 52 & 53 of the DERC Supply Code and Performance Standards Regulation, 2007. He is R/o House no. 540, First Floor, Jheel Khuranja Delhi 110031 and having electricity connection K. No 1220R6240421.

2. The Respondent has filed an affidavit on 29.09.2011 stating that the aforesaid matter had already been amicably settled between petitioner and respondent company in December, 2010 and petitioner has made complete payment as per the settlement.
3. In pursuance of the above affidavit, Commission issued a letter to the Petitioner seeking confirmation from him on the above settlement and gave 15 days time to reply from the receipt of letter. The letter was issued on 07.10.2011.
4. The Petitioner was also informed through this letter that in absence of his non-submission of confirmation, it will be presumed that he is no more interested to press his prayer /grievance and the said complaint shall be treated as amicably settled and withdrawn.
5. However, the Respondent through his covering letter has filed an application dated 29.11.2011 of the complainant, which is addressed to the Commission and has been signed by the counsel of the complainant, wherein, the complainant has sought withdrawal of his present complaint.
6. The above matter was listed on 28.02.2012 for hearing in the Commission which was attended by above representatives of the Respondent however, no one appeared on behalf of the complainant. The Commission while acceding to the request of the complainant for withdrawal of his complaint and subsequent request of the Respondent for disposing off the above complaint in terms of amicable settlement decide to dispose off the above complaint considered as amicably settled and withdrawn.
