A. INTRODUCTION

- 1.1 State Load Despatch Center (SLDC), has filed the Petition for Approval of True-up of Expenses for FY 2021-22 and approval of Aggregate Revenue Requirement (ARR) for FY 2023-24.
- 1.2 This Executive Summary contains the summary of the Petition filed by SLDC for True-up of FY 2021-22 and approval of ARR for FY 2023-24.
- 1.3 The True-up of FY 2021-22, ARR and Tariff for FY 2023-24 shall be based on the provisions of DERC (Terms and Conditions for Determination of Tariff) Regulations, 2017 and DERC (Business Plan) Regulations, 2019, DERC (Business Plan) Regulations, 2023 and DERC (Levy and Collection of Fee and Charges by State Load Despatch Centre) Regulations, 2007, after prudence check.
- 1.4 The figures of various components in the Executive Summary have been extracted from the Petition filed by SLDC and the complete petition is also available on DERC website https://www.derc.gov.in/

B. TRUE-UP OF FY 2021-22 AND ARR FOR FY 2023-24

- 1.5 As per the Provision of 4(3) of the *DERC (Levy and Collection of Fee and Charges by State Load Despatch Center) Regulations, 2007*, the Annual charges to be recovered by the SLDC shall include component of Return of Equity/ Investments and also the following expenses:
 - a) Employee Cost;
 - b) Administrative and General Expenses;
 - c) Repairs and Maintenance Expenses;
 - d) Depreciation;
 - e) Advance against Depreciation;
 - f) Interest and Finance Charges;
 - g) Interest on working capital, if any;
 - h) Any other expenses incidental to discharge the functions of SLDC as deemed appropriate by the commission.
- 1.6 The True-up of FY 2021-22 and ARR for FY 2023-24 is tabulated below:
