Subject: - Fuel Price Adjustment Surcharge reg:-

Sir,

1. The Commission has received applications dated 24.04.12 from TPDDL (NDPL), 21.04.2012 from BRPL & 23.04.2012 from BYPL regarding Fuel Price Adjustment Surcharge for the quarter Jan. - March, 2012 in compliance with the order of the Commission dated 26.08.2011.
2. TPDDL (NDPL), BRPL & BYPL have sought an increase in variable part of tariff of 4.67%, 7.27%, & 9.23% respectively on account of fuel price adjustment surcharge.
3. On the basis of the information submitted by the Discoms and considering the first power purchase bills (excluding arrears) and billed amount reflected in the auditor's certificate, the Commission approves the following Fuel Price Adjustment (FPA) charges for the quarter ending March, 2012 on a provisional basis:-

TPDDL (NDPL)	4.0%
BRPL	6.0%
BYPL	7.0%

4. It is clarified that Fuel Price Adjustment is a component of tariff and its application shall be in the same manner as in the case of a tariff revision i.e. it shall be applicable only on the pro-rata consumption with effect from 01-05-2012. Further, it is clarified that the above FPA is to be levied only on the energy consumed from 01.05.2012 onwards for a period of 3 months upto 31.07.2012. The consumption shall be determined on a pro-rata basis if meter reading is taken before 01.05.2012 or after 31.07.2012.

5. This issues with the approval of the Commission.
