 Ld. Counsel, Mr. Amit Kapoor, Advocate, appearing for BRPL advanced his preliminary arguments. He further submitted that at least 3-4 days time may be granted for submitting a detailed reply to the Notice No. F.11(748)/DERC/2011-12/4035 dated 19.11.2011 issued by the Commission.

- 2. Mr. Y.V.V.J. Rajasekhar, Jt. Secretary (Power), Govt. of NCT of Delhi submitted that BRPL and BYPL have defaulted in making payments to many Central and Delhi State Generation and transmission utilities including DTL, IPGCL & PPCL. He also requested the Commission to grant at least 3-4 days time to submit the response of Govt. of NCT of Delhi in this matter.
- 3. The Commission heard Ld. Counsel, Mr. Kapoor, Advocate, BRPL and Sh. Rajasekhar, Jt. Secretary (Power) at some length. The Commission also heard Mr. Roop Kumar, GM (SLDC), Mr. I.A. Khan, SJYN and Mr. Prashant Sharma, GM (Comml.) Power Grid.
- 4. The Commission has already directed the distribution utilities to file the details regarding their month-wise cash flows since April, 2011 and their utilization under specified heads (vide letter No. F.3 (326)/Tariff/DERC/2011-12/C.F.No. 3131/3611 dated 27.10.2011), duly certified by the Statutory Auditors. These are required to be furnished latest by 23.11.11.
- 5. The Commission further directs BRPL to file their reply to Notice dated 19-11-2011 latest by 25.11.2011 with the Commission with an advance copy to Principal Secretary (Power) GoNCTD. GoNCTD may also file their response with the Commission with an advance copy to BRPL. The Commission directs that the service of all replies, responses and copies be completed by 25.11.2011.
- 6. The matter is listed for further hearing on 28.11.2011 at 3:30pm in the Office of the Commission.
