INTERIM ORDER

(Date of Hearing: 09.07.2015) (Date of Order: 17.07.2015)

- The instant petition has been filed by Shri Idrish Ahmad, under Section 142 of the Electricity Act, 2003 against BSES Rajdhani Power Ltd. for violation of the procedure laid down in Regulation 52 of the Delhi Electricity Regulatory Supply Code and Performance Standards Regulations, 2007.
- 2. The matter was listed for hearing in the Commission for admission today, which was attended by the Counsel/representatives of both the parties.

3. During the hearing, Mr. M. K. Banka, the authorized representative of the

Petitioner submitted that the Respondent has not analyzed the consumption

pattern and claimed that the consumption units were more than 75% of the

assessed units.

4. The Counsel for the respondent objected that the case before the

Commission may be presented by either the complainant or his appointed

counsel and not by anyone else.

5. The Commission held that being a quasi-judicial body, an authorized

representative well versed with the facts may present the case before the

Commission.

6. The Counsel for the respondent further contended that the claim of the

petitioner about assessed units/consumed units is pending before the CGRF

and the next date of hearing is 22.07.2015.

7. Considering the fact that the matter is under adjudication with CGRF, the

hearing was adjourned with the direction to the Petitioner to submit the case

on the basis of the final Order of the CGRF.

8. The next date of hearing to decide about the admission of the Petition shall

be intimated to the parties in due course.
