INTERIM ORDER

(Date of Hearing: 22.08.2013) (Date of Order: 03.09.2013)

- 1. The matter was listed for hearing on 22.08.2013 in the Commission after notice issued by the Commission for the complaint filed by the Petitioner under Section 142 of the Electricity Act, 2003.
- 2. The Petitioner submitted that the Respondent has not complied with the directions contained in the notice dated 18.06.2013 whereby the Respondent was directed to file a reply to the petition within two weeks with a copy to the petitioner.

- 3. The Counsel for the Respondent submitted that he could not file reply in time and tendered apology for the same. He further submitted that he has brought the reply and seeks permission of the Commission to file the same.
- 4. The Commission allowed the Respondent to file its reply.
- 5. The Counsel for the Respondent filed reply to the petition with copy of the same supplied to the Petitioner.
- 6. The Commission perused the reply submitted by the Respondent and heard both the parties on limited issues and directed the Respondent to file reply to the following queries, within two weeks.
 - i) Analysis of data downloaded from the seized meter so as to arrive at the conclusion of the theft.
 - ii) Name and designation of officer of BYPL who was authorized to conduct personal hearing on 24.12.2012.
 - iii) A copy of the notice issued for disconnection of power supply.
 - iv) How the amount of theft was assessed with respect to connected load.
- 7. The next date of hearing shall be intimated to the parties in due course.
- 8. Ordered accordingly.
