INTERIM ORDER

(Date of Hearing 19.07.2016) (Date of Order: 01.08.016)

- 1. The instant Petition came up for hearing on 19th July, 2016, which was attended by Counsel of the Petitioner.
- 2. Ld. Counsel for the Petitioner advanced his arguments for admission of the Petition and submitted the following that ;
 - a. M/s BYPL has proposed a program for implementation of Energy Efficient Fans Programme (EEFP) for Fans in household sector and commercial sector in Delhi. As per the proposal, the capital investment required for implementation of the program will be made by the ESCO i.e M/s Energy Efficiency Services Limited (EESL), New Delhi and the DISCOM shall make payment to EESL by recovering the cost from consumers in 24 monthly instalments.
 - b. Under the program, the DISCOM along with the technical and financial support of EESL has envisaged to undertake the following tasks:
 - (i) The EESL will undertake distribution of BEE five star rated fans: upto maximum 2 fans to Domestic consumers on On Bill Financing mode & unlimited fans to Domestic consumers on upfront mode and unlimited number of fans to Commercial Consumers on upfront mode in the entire area of BYPL in Delhi.

- (ii) Domestic Consumers can buy BEE 5 star rated ceiling fans either on upfront payment option or On Bill Financing (OBF) option. Commercial consumers can buy BEE 5 Star rated ceiling fans only on Upfront Payment option.
- (iii) Under upfront payment option, Consumer can buy BEE 5 star ceiling fans by paying entire amount upfront. Consumer shall make upfront payment (One-time payment of Rs. 1300 per fan). Domestic and Commercial consumer may avail unlimited fans under upfront payment option.
- (iv) Under On Bill Financing (OBF) option, the total cost will be recovered through monthly electricity bill over 24 installments of Rs. 62 each. Domestic consumer can avail up to fans under OBF option. Only domestic consumers with no arrears in last three consecutive billing cycles will be eligible for availing OBF option.
- (v) The actual price will be discovered through open competitive bidding. Any benefits realized during price discovery shall be passed on to consumers.
- 3. The Commission heard the Petitioner at length and admits the Petition.
- 4. The Commission directs Tariff Division to examine various aspects of the proposal raised in the Petition and submit a report within two weeks to the Commission for its consideration.
- 5. The next date of hearing will be informed in due course.
- 6. Ordered accordingly.
