INTERIM ORDER

(Date of Hearing 19.07.2016)

(Date of Order: 01.08.2016)

1. The instant Petition came up for hearing on 19th July, 2016, which was attended by Counsel and representatives of the Petitioner.
2. Ld. Counsel for the Petitioner advanced his arguments for admission of the Petition and submitted that ;
 - a. M/s BRPL has proposed a Demand Side Management (DSM) based program for implementation of Domestic Efficient Fans Programme (DEFP) for Fans in Delhi. As per the proposal, the capital investment required for implementation of the program will be made by the ESCO i.e M/s Energy Efficiency Services Limited (EESL) and the cost will be recovered from the consumers through upfront mode.
 - b. The petitioner has submitted that under the program, the DISCOM along with the technical and financial support of EESL has envisaged to undertake the following tasks:
 - (i) EESL will undertake distribution of 1,50,000/- BEE five star rated fans: unlimited number of fans to each Domestic consumer and unlimited

number of fans to each Commercial Consumers in the entire area of BRPL in Delhi.

(ii) Domestic Consumers and Commercial consumers can buy BEE 5 star rated ceiling fans either on upfront payment of Rs. 1300 each fan.

(iii) The actual price will be discovered through open competitive bidding. Any benefits realized during price discovery shall be passed on to consumers.

c. The implementation of DEFP in the area of BRPL would result into energy savings of 14.18 Million units per annum.

d. The Fans will be distributed from designated counters set up in various locations in Delhi. These locations will be mapped in consultation with the state agencies and could include billing centres of DISCOMS, SEWA Kendras, prominent locations like schools, etc. EESL will engage distribution agencies that will help set up the distribution counters and ensure smooth distribution of Fans. Further, a state-wide campaign will be designed and implemented to support the programme.

3. The Commission heard the Petitioner at length and admits the Petition.

4. The Commission directs Tariff Division to examine various aspects of the proposal raised in the Petition and submit a report within 2 weeks to the Commission for its consideration.

5. The next date of hearing will be informed in due course.

6. Ordered accordingly.
