INTERIM ORDER

(Date of Hearing: 27.06.2013) (Date of Order: 03.07.2013)

- 1. The above matter was listed for hearing today in the Commission; where above named representatives of both the parties were present and submitted their arguments on the issue of admission of this petition.
- 2. The Petitioner submitted that the Respondent is not providing IP connections even after 2 ½ years of application and therefore, is violating the regulations. The petitioner also submitted that on the same plot, the respondent

has provided IP connections to four other persons and is adopting a pick and choose policy. The petitioner also submitted that as per verbal advice of the respondent, they also made a platform for installation of the required transformer so that IP connection may be given to them. They also got issued a letter from East Delhi Municipal Corporation regarding providing space for installation of transformer. Despite all efforts made by the petitioner, the Respondent is not ready to provide IP connection and is adopting a pick and choose policy.

- 3. The Respondent submitted that the erstwhile big plot has now been divided into small plots and has been given to various persons including the petitioners. The Respondent also submitted that for supply of electricity to all new applicants, a transformer has to be installed and they do not have space to install the transformer and provide electricity to them. The Respondent contended that if the space is provided for installation of transformer, electricity connection may be given after installation of a transformer.
- 4. After hearing both the parities, the Commission observed that a spot inspection may be carried out along with representatives of all concerned parties and a status report furnished for further action.
- 5. The Commission directs that a copy of these proceeding may be sent to ED (Engg.) to depute a team of officers to inspect the site and submit their report within one month.
- 6. Ordered accordingly.
