INTERIM ORDER

(Date of Hearing 24.10.2017) (Date of Order: 03.11.2017)

The Hon'ble Appellate Tribunal for Electricity vide judgment dated 15.05.2017 has remanded back the matter to the Commission with the direction to examine the submissions made by the petitioners and give an opportunity to the petitioners to place their case on merits. Hence, the present petitions are being heard.

- 2. The Counsel for the petitioners submitted that they have filed the year wise consolidated figures of balance of consumer contribution as per the directions given in the Order dated 23.12.2015 of the Commission.
- 3. The petitioners are directed to provide, within four weeks, the exact figure of the amount to be refunded to the respective consumers with the date from which it has to be refunded alongwith the provision of relevant tariff orders in which it was considered as means of finance.
