INTERIM ORDER

(Date of Hearing: 17.10.2017) (Date of Order: 24.10.2017)

- The Instant Petitions have been filed by M/s TPDDL seeking approval of the Commission to discontinue power procurement from the PPAs, commercial arrangement and agreement made with M/s NHPC Ltd. and M/s THDC India Ltd.
- 2. Mr. M.G. Ramachandran, Advocate for M/s THDC India Ltd. submitted the plea that it is beyond the jurisdiction of the Commission to decide on the issue of surrender of power and such matter may be decided by the Central Government only.
- 3. It is ruled that this Commission is deliberating on the limited issue whether surrender of allocated power from certain stations of the Respondents merits any recommendation from the Commission so as the petitioner may approach the Central government in this regard.
- 4. It is a fact that with the passage of time the cost of power from hydroelectric plants of Respondents may perpetually decrease because of the recovery of cost through depreciation and therefore, economic viability of surrender of power has to be seen.
- 5. The Petitioner is directed to submit a cost benefit analysis till the period of validity of the PPA for each station within three weeks with a copy to the Respondents. The Respondents may file their submission on the cost benefit analysis within two weeks thereafter, with an advance copy to the Petitioner.
- 6. The next date of hearing will be intimated in due course.
- 7. Ordered accordingly.
