#### **INTERIM ORDER**

(Date of Hearing: 17.10.2017) (Date of Order: 24.10.2017)

- The instant Petition has been filed by Tata Power Delhi Distribution Ltd. (TPDDL) for interpretation/Clarification Clause of Tariff Order dated 31.08.2017. The petitioner has, inter alia, made following prayers in its petition:
  - a) Relaxation in compliance of Regulation 4 of Renewable Purchase Obligation Regulations, 2012 which provides for RPO obligation for the period FY 2012-13 to FY 2016-17;
  - b) Waiver of Penalty of Rs. 25.13 crores imposed vide Tariff Order dated 31.08.2017.

- 2) The Counsel for the Petitioner submitted that the Petitioner has been making sincere efforts to fulfil the Renewable Purchase Obligation but due to some reasons beyond its control it may take some more time to fulfil the obligation and to clear the backlog. On the query that by what date the Petitioner will discharge its Renewable Purchase Obligations, the Counsel for the Petitioner submitted that the Petitioner will comply with the Renewable Purchase Obligations by the end of this quarter i.e. 31.12.2017.
- 3) The Petition is admitted. The Petitioner is directed to file an undertaking on an affidavit in respect of compliance of RPO by the end of this quarter. The request of the Petitioner for relaxation shall be considered accordingly. However, any relaxation in fulfilment of RPO shall be without prejudice to the proceedings u/S 142 of the Electricity Act, 2003.
- 4) The next date of hearing shall be informed to the parties in due course.
