1. The present Petitions have been filed by the Petitioners seeking directions for relaxing the provisions of DERC (Terms and conditions for Open Access) Regulation, 2005 to allow the implementation of the Electricity (Promoting

Renewable Energy Through Green Energy Open Access) Rules, 2022 notified on 06.06.2022 as an interim measure through appropriate orders/directions.
