- The present petitions have been filed by BSES Rajdhani Power Ltd. (BRPL) &
 BSES Yamuna Power Ltd. (BYPL) with respect to waiver of Renewable Power
 Obligation (RPO) targets for the Petitioners for the year 2013-14, 2014-15 &
 2015-16 and deferment of the compliance thereof.
- 2. The Intervention Applications of M/s National Solar Energy Federation of India and Green Energy Association have been allowed vide interim order dated 11.07.2016.
- 3. The matter came up for hearing today, which was attended by Counsel and representatives of the Petitioners and Interveners.
- 4. The Counsel for the Intervener namely M/s National Solar Energy Federation of India submitted that as the copy of the Petition has not been received by it till date, two weeks time may kindly be granted to file a reply on the Petition and Petitioners be directed to supply a copy of the Petition.
