# **INTERIM ORDER**

1. Heard Mr. Tushar Sannu in Petition No. 08/2021 as well as in Petition No. 33/2021. Let these two be connected together and listed together in future. Mr. Tushar Sannu has informed that vide this Petition No. 08/2021, the NDMC is seeking approval of the Commission for the two minor deviations from the model bidding documents for procurement of 142MW Hydro Power on medium term basis i.e. for three years and further extendable up to two years. In this regard, the DERC office has informed that a letter dated 21.10.2020 was addressed to the Chairperson of NDMC, for information required to be furnished by the Petitioner.

However, Mr. Tushar Sannu has submitted that this letter has already been replied and the information sought by DERC has become redundant in view of the latest development as per the Electricity Act, 2003.
