### **INTERIM ORDER**

(Date of Hearing: 17.12.2015)

(Date of Order: 29.12.2015)

1. The instant petition has been filed by Sh. Jasbir Singh under Section 142 of the Electricity Act, 2003 against Tata Power Delhi Distribution Ltd. for violation of the procedure laid down in the Delhi Electricity Regulatory Supply Code and Performance Standards Regulations, 2007.
2. On the date of last hearing i.e. on 20.08.2015, the Commission had directed the Respondent to restore electricity supply to the Petitioner temporarily for one month and also directed the Petitioner to approach the Court of the

ADM for further relief in this regard as the Order of restoration was given by the Court of the ADM (Additional district Magistrate), Kirpa Narain Marg/ Sham Nath Marg.

3. The matter was listed for hearing today i.e. on 17.12.2015, wherein the Counsel/representatives of both the parties were present. During the hearing, the representative of the Petitioner submitted that as per the directions of the Commission, he has filed the case before the Court of the ADM, Kirpa Narain Marg/ Sham Nath Marg, which is in advance stage.
4. Keeping in view the above, the Commission adjourned the matter with a direction to the Petitioner to inform the Commission about the final outcome of the case pending before the Court of the ADM, Kirpa Narain Marg/ Sham Nath Marg. The case will be listed after disposal of the case pending before the Court of the ADM.
5. The next date of hearing to decide about the admission of the Petition shall be intimated to the parties in due course.
