INTERIM ORDER

(Date of Hearing: 03.12.2015) (Date of Order: 23.12.2015)

- The instant petition has been filed by Shri. Mahboob Anwar under Section 142
 of the Electricity Act, 2003 against BSES Rajdhani Power Ltd. for violation of
 the procedure laid down in the Delhi Electricity Regulatory Supply Code and
 Performance Standards Regulations, 2007.
- 2. A notice of the petition was issued on 19.08.2015 to Respondent to file its reply.
- 3. In response to the above notice, the Respondent filed its reply on 30.11.2015.

- 4. The matter was listed for hearing today wherein both the parties were present. During the hearing, the proxy counsel for the Respondent sought adjournment on the ground that the arguing counsel was not present. The Petitioner objected to it and submitted that the Respondent was supposed to file reply within four weeks from the date of notice dated 19.08.2015. However, the Respondent did not comply with the notice and has failed to provide a copy of reply. The Commission took exception to the fact of non-submission of reply in time and imposed a cost of Rs. 2000/- on the Respondent.
- 5. A copy of the reply was served upon the Petitioner at the time of hearing. The Petitioner sought time to file rejoinder to the reply of the Respondent.
- 6. The Commission granted two weeks time to the Petitioner to file rejoinder with a direction that a copy be served upon the Respondent. Commission also directed the respondent to pay the cost of Rs. 2000/- (Two Thousand Only) to the Petitioner within a week.
- 7. The next date of hearing shall be intimated to the parties in due course.
- 8. Ordered accordingly.
