# <u>ORDER</u>

Date of Hearing: 28.02.2012 (Date of Order: 12.03.2012)

The instant complaint has been filed by Ms. Manju Rani, against the
Respondent company for not giving permanent domestic connection
at her Plot no. 3-A/1, Vikas Nagar Opposite Hanuman Mandir, Uttam
Nagar, New Delhi – 110059 against already exiting temporary
connection by also installating of electric Pole.

- 2. The brief matrix of the case is that she has applied for permanent domestic connection for Plot no. 3-A/1, Vikas Nagar Opposite Hanuman Mandir, Uttam Nagar, New Delhi 110059against already exiting temporary connection for which installation of electric Pole was required. In this regard she has deposited Rs. 4200/- on 10.01.2008. Even after her repeated requests the above connection was not issued which is incontravention of Regulation made under DERC Supply Code, 2007.
- 3. In response to the above, Respondent has filed its reply dated 10.06.2011, stating therein that the grievance of the consumer for non-installation of meter along with pole has been resolved and a meter no. 24346533 has been installed at her premises on 10.06.2011. In support of its claim the Respondent has also filed a copy of the consumer satisfaction and withdrawal of her complaint.
- 4. In pursuance of the above reply of Respondent, Commission issued a letter to the Petitioner on 15.06.2011 seeking confirmation from her on the above withdrawal letter.
- 5. The above matter was listed on 28.02.2012 for hearing in the Commission which was attended by above representatives of the Respondent however, no one appeared on behalf of the complainant. The Commission while acceding to the request of the complainant for withdrawal of her complaint in terms of redressal of her grievance decides to dispose off the above complaint as amicably settled and withdrawn.
