ORDER

1. The instant complaint has been filed by Mohd Abdul Kalam against the Respondent company under section 142 of the Electricity Act, 2003. He is R/o 11123/2,Gali Swarn Wali, Motia Khan, Pahar Ganj, Delhi and having electricity connection K. No. 1130P52005587.

2. The Respondent has filed an affidavit on 26.12.2011 stating that the aforesaid matter has already been amicably settled between petitioner and Respondent company.
3. In pursuance of the above affidavit, Commission issued a letter to the Petitioner seeking confirmation from him on the above settlement and gave 15 days time to reply from the receipt of letter. The letter was issued on 26.12.2011.
4. The Petitioner was also informed through this letter that in absence of his non-submission of confirmation, it will be presumed that he is no more interested to press his prayer /grievance and the said complaint shall be treated as amicably settled and withdrawn.
5. However, the Respondent through his affidavit has enclosed a copy of Settlement Deed dated 15.12.2011, which has been signed by both the parties, wherein, the complainant has sought withdrawal of his present complaint.
6. The above matter was listed on 28.02.2011 for hearing in the Commission which was attended by above representatives of the Respondent & complainant. The Commission taking cognizance on the settlement deed filed by Respondent and duly signed by complainant, disposes off the above complaint in terms of amicable settlement.
