1. The instant complaint has been filed by Mohd. Ashraf, against the Respondent company under section 142 of the Electricity Act, 2003 for violation of Regulations 52 & 53 of the DERC Supply Code and

Performance Standards Regulation, 2007. He is R/o 4289, Basement, Gali Shahtara, Ajmeri Gate, Delhi-110 006 and having K. No. 111017670078 for non-domestic purpose with 4 KW sanction load
