1. The present petition has been filed by Sh. Munish Singla against Tata Power Delhi Distribution Ltd. under section 142 of the Electricity Act, 2003 for violation of procedures laid down in Regulation 52 & 53 of DERC Supply Code and Performance Standards Regulations, 2007, while booking a DAE case in respect of his electricity connection CA NO.60010367070.

2. Notice of the petition was issued to the respondent on 09.08.2010 to file its reply.
3. The Counsel for the respondent has submitted that since the case of theft booked against the above complainant has been dropped, therefore, no grievance of the complainant survive. Hence, the above complaint may kindly be disposed-off.
4. In support of the above, the respondent has also filed an application for withdrawal of the above complaint from the complainant, which has been signed by the Counsel for the complainant wherein the complainant has also requested to allow withdrawal of his complaint as the DAE case made against him has already been dropped by the respondent.
5. After perusal of the entire records, it seems that the grievance for which the petitioner has filed the present petition before this Commission has already been resolved and petitioner has no grievance against the respondent.
6. In view of the above, this Commission decides to accept to the request of the complainant and dispose-off the above complaint considering the same as withdrawn.
