# **INTERIM ORDER**

The above matter was listed for hearing today in the Commission; wherein above named representatives of both parties were present. In the course of hearing, the complainant invited the attention of the Commission to para 11 of his plaint and sought action against the Respondent for

disconnection of his supply on 08.02.2011 by the Respondent, without issue of any show cause notice under section 56(1) of Electricity Act, 2003. The above action of the Respondent was also in-contravention of the order of the CDRF dated 15.11.2006.

- 2. When the Respondent was asked to respond to the above allegation, the counsel of the Respondent sought time to file the exact status on the above.
- 3. In view of the above, the Respondent is directed to file its reply on the above allegation i.e. whether his action of disconnection of supply of the complainant was in conformity with the provisions made under Section 56(1) of the above Act and if so, then file the copy of the disconnection notice served on the consumer under the above provision before taking the above action.
- 4. The matter shall now be listed for hearing on 08th May, 2012.
