PUBLIC NOTICE REQUEST FOR PUBLIC RESPONSE

Petition for approval of Aggregate Revenue Requirement for Distribution (Wheeling and Retail Supply) Business for FY 2011-12 and True up for FY 2009-10

- New Delhi Municipal Council (hereinafter referred to as "NDMC") has filed its True-up Petition for FY 2009-10 and Determination of Corresponding Tariff of FY 2011-12 on March 10, 2011 before the Delhi Electricity Regulatory Commission (hereinafter referred to as "Commission") for determination of Aggregate Revenue Requirement (ARR) and correspoonding Tariff adjustment for FY 2011-12 under the provisions of the Electricity Act, 2003, Delhi Electricity Reform Act, 2000 to the extent applicable and the Distribution Tariff Regulations issued by the Commission dated May 30, 2007.
- The salient features of Petitions are provided below:

- 3. Recovery of Revenue Gap up to FY 2011-12 - In order to recover this entire gap of 244.72, the average tariff (fixed and energy charges) will be required to be increased by 39% for FY 2011-12.
- NDMC has proposed a hike of Rs. 1.23, Rs. 2.04, Rs. 2.25, Rs. 1.65 and Rs. 1.44 for Domestic, Non-domestic, Mixed Load, Small Industrial Power and Public lighting respectively from its existing tariff for the FY 2011-12.
- 5. Performance of NDMC during FY 2009-10:
 - Loss Reduction: The AT&C loss level has reduced to 12,46% during the year consisting of 10.71% of Distribution losses at a collection efficiency of 98.04%. The above AT&C loss level has been achieved by reducing losses by 0.57% from the previous loss level of 13.03%.
 - Reliability: Average system availability index during the period 2009-10 was also more than 99%.
- In accordance with the provisions of the Delhi Electricity Regulatory Commission Comprehensive (Conduct of Business) Regulations, 2001 notified by the Commission, the consumers and stakeholders are requested to submit the response on the above Petition.
