**ORDER**

(Date of Order: 16.06.2025)

1. In exercise of powers under the proviso to Regulation 121 (4) of the DERC (*Terms and Conditions for Determination of Tariff*) Regulations, 2017 which enables the Commission in reassigning the allocation of Power amongst the Distribution Licensees out of the overall power portfolio allocated to the National Capital Territory of Delhi by Ministry of Power, Government of India, the allocation of power from NHPC (Parbati-II, Teesta-VI & Rangit-IV), is hereby ordered as detailed hereunder.
2. The Commission has received a letter dated 11.03.2025 from the Department of Power, GoNCTD, requesting comments on the letter dated 25.02.2025 from the Hydel Division of Ministry of Power (Govt. of India), w.r.t the allocation of firm power from Dibang multipurpose project (2880 MW), Parbati-II (800 MW), Teesta-VI (500 MW), and Rangit-IV (120 MW) Hydro-electric projects of NHPC Ltd. and its subsidiary. In this regard a letter, dated 04.04.2025, of Allocation was sent to the DISCOMs of Delhi, SLDC and Department of Power, GoNCTD.

3. Ministry of Power, GOI, has allocated 62 MW Power to Delhi from three Hydro-Electric Projects as follows:

4. In this regard, a meeting was scheduled with DISCOMs which was attended by representatives from TPDDL, BRPL, BYPL and NDMC. The comments received from all the DISCOMs are summarized as follows:

- a) BRPL, BYPL, and NDMC expressed willingness to procure power from all three NHPC Projects.
- b) TPDDL expressed willingness to procure power only from Parbati-II.
- c) All DISCOMs agreed that the power may be allocated in the ratio of energy drawl as per last five years' data.

5. The Commission, in order to finalise the allocation of Power to DISCOMs, has considered the average of DISCOM-wise Energy drawl data of past 5 years, i.e., for the period of FY 2019-20 to FY 2023-24 from the Annual Report of Delhi-SLDC, which is as follows:
