#### **ORDER**

(Date of Order:12.03.2018)

- 1. M/S BSES Rajdhani Power limited (BRPL or DISCOM) has submitted the present Petition for implementation of Energy Efficient Fans Programme (EEFP) for Fans in household sector and commercial sector in Delhi.
- 2. The proposal as contained in the petition was that the capital investment required for implementation of the program will be made through an Energy Service Company i.e M/s Energy Efficiency Services Limited (EESL), New Delhi and BRPL shall make payment to EESL by recovering the cost from consumers in 24 monthly instalments.
- 3. The Commission vide interim order dated 28.04.2017 has enquired from the petitioner whether the instant programme is in variance to or in line with the similar DSM Programme for efficient lighting project for LED Bulbs in Delhi and would it be appropriate to approve the instant programme on the similar lines. In response, the petitioner vide letter dated 16.02.2018 has submitted that the instant Fan Scheme is in line with the ongoing DSM Scheme viz. "Domestic Efficient Lightening Programme" (DELP) for efficient lighting programme for LED bulbs in Delhi implemented through Energy Efficiency Services Ltd. (EESL).

4. The Commission has approved a similar petition for DSM scheme of efficient fans filed by M/s BYPL, which was tagged with the present petition. This petition is also allowed on the similar lines. Accordingly, the Commission approves this programme as under:

## i. <u>Discounted Price:</u>

The BEE 5 Star rated fans will be given through upfront payment mode at a price arrived at by taking into consideration the bidding price and other expenses subject to a ceiling of Rs. 1150 per fan.

### ii. Expenses in ARR:

Any expenses/income incurred on account of implementation of UJALA Programme will not be pass through in Annual Revenue Requirement.

#### iii. Eligibility of Consumers:

- a. The consumer should have a valid consumer connection number/CA number.
- b. There shall be no outstanding dues as on date of application.
- c. Unlimited Fans to be offered to Domestic Consumers.
- d. The Programme shall be applicable on first come first serve basis for the eligible consumers.

## iv. <u>Implementing Agency:</u>

EESL shall be responsible for overall implementation of UJALA-Program for BEE 5 star rated Fans in the operation area of DISCOM.

# v. <u>Validity of the Programme:</u>

The Programme shall be valid upto 31<sup>st</sup> December, 2018. The Commission may consider extension of the date of instant Programme on a request made by the DISCOM.

5. The case is accordingly disposed of.
