Subject: - Power Purchase Cost Adjustment Charges (PPAC) reg:-

Sir,

The Commission has received applications dated 21.01.2013 from TPDDL, BYPL & 23.01.2013 from BRPL regarding Power Purchase Cost Adjustment Charges (PPAC) for the quarter Oct.- Dec., 2012,(Q3) in compliance with the order of the Commission dated 13.07.2012.

2. TPDDL, BYPL & BRPL have sought an increase of 2.80%, 7.44%, & 9.18% respectively on account of Power Purchase Cost Adjustment Charges for Q3.

3. Preliminary Examination of the applications of BYPL & BRPL reveals that the claims of PPAC have been made including the bills relating to supplementary & past arrears along with cost towards power purchased during the quarter Oct. - Dec., 2012 whereas the claim of TPDDL is based on current bills. In order to assess the impact of PPAC, the Commission has decided not to consider the supplementary bills and those relating to past arrears. Such an approach had been adopted for evaluating the Fuel Price Adjustment Charges (FPAC) earlier as well.

4. On the basis of the information submitted by the Discoms and considering the first power purchase bills raised by Generation Companies excluding arrears etc. & fixed cost paid to NHPC due to regulation of power (wherever applicable), the Commission approves the following Power Purchase Cost Adjustment Charges for the quarter Oct.- Dec., 2012 on a provisional basis:-


TPDDL	1.5%
BYPL	3.0%
BRPL	3.0%

5. It is clarified that Power Purchase Cost Adjustment Charges is a component of tariff and its application shall be in the same manner as in the case of a tariff revision i.e. it shall be applicable only on the pro-rata consumption with effect from 01-02-2013. Further, it is clarified that the above PPAC is to be levied only on the basis of energy consumed from 01.02.2013 onwards for a period of 3 months upto 30.04.2013. The consumption shall be determined on a pro-rata basis if meter reading includes the consumption of the period before 01.02.2013 or after 30.04.2013.

- a) The percentage increase on account of PPA will be applied as a surcharge on the total energy and fixed charges (excluding arrears, LPSC, E-Tax etc.) billed to a consumer of the utility.
- b) The bill format shall clearly identify the PPA percentage and amount of PPA billed as separate entries.

This issues with the approval of the Commission.
