- 2. After hearing the argument advanced by the representatives of the petitioner and the available record, the Commission issued the following directions:-
 - On the issue of determination of Tariff for 1 MWp Grid interactive Solar
 PV Power Project the petition is admitted
- 3. The Commission has already issued an order indicating the terms and conditions for energy generated through Solar PV which is put on the website on 9th July, 2010. Petitioner may sign the PPA with the distribution licensee and submit the same for approval of the Commission as per the provisions of the said order referred above.

• On the issue of 2.5 MW Gas Turbine Power Project :

- 4. So far as the Gas Turbine Plant is concerned, the petition will be considered for admission after the following:
 - a) A PPA is signed with the distribution licensees purchasing power.
 - b) Gas is contracted to be procured at a price which makes the project commercially viable.

The petitioner is directed to file a supplementary petition after compliance of the above.
