- 1. The Commission heard the arguments advanced by the Ld. Counsel for the Petitioner primarily on maintainability at some length.
- 2. The Commission after hearing the arguments made by the Petitioner raised the following queries on this Petition;
 - a. The duration of power supply under the said Power Purchase Agreement.

- b. Whether any power was supplied from the same generating unit to any other power purchaser by invoking the jurisdiction of CERC for determination of tariff for power supplied during the above period.
- c. If so, the Petitioner may file copies of the Petition filed by them before CERC and the order passed by CERC for determination of tariff.
- 3. In response to the said queries of the Commission, the petitioner made a request for grant of some time to place on record the relevant information on an affidavit. The Commission has accepted the request of the Petitioner and grants liberty to file said additional information before the Commission within a week with an advance copy to the respondents to file a rejoinder, if any, within a week after receipt of additional information from the Petitioner.
