1. Mr. Buddy A Ranganadhan , the Learned Counsel for BRPL & BYPL submitted that since the Interlocutory Application (IA) filed by the petitioners have not been controverted by any of the respondents therefore the issues and statement as submitted in the IAs are construed by the parties to be accepted. On this issue the Generation companies (Gencos) and Transmission Companies (Transcos) i.e SJVNL, IPGCL/PPCL, DTL, NHPC and PGCIL submitted that they have not received a copy of the IAs and they intend to submit their replies.
2. The Commission directed BRPL and BYPL to provide copies of IAs and copies of the reply filed before the Commission to Gencos, Transcos. Govt. of NCT of Delhi and all interested parties in the matter, within 3 days from the date of hearing i.e by 06.05.2015 and thereafter all concerned parties may file their replies within a week with an advance copy to BRPL and BYPL. In case the interested parties do not receive a copy of the IA from the Respondents (BRPL/BYPL) within a week, they may apply and obtain it from the office of the Delhi Electricity Regulatory Commission.
