- 1. The Commission heard Mr. Amit Kapur, Ld. Counsel for BRPL & BYPL at some length.
- 2. Ld. Counsel Mr. Kapur placed before the Commission a compilation of earlier orders passed by the Commission and Appellate Tribunal for Electricity and letter of Govt. Of NCT of Delhi dated 03.02.2014 to DERC reg. Alleged Paucity of funds with DISCOMs and their likely failure to supply power to consumers for long hours and letter dated 05.02.2014 issued by BSES to Secretary (Power), GoNCTD re. Urgent steps required to resolve power crises. The same is taken on record.
- 3. In response to the query of the Commission that no reply/comments against letter no. F.11(101)/2007/Power/Pt./383 dated 03.02.2014 of GoNCTD addressed to Hon'ble Chairperson, DERC was filed by the DISCOMs. Mr. Kapoor made a request for grant of time upto 08.02.2014 to file the reply. The Commission has accepted the request and directed BRPL & BYPL to file their reply/comments on or before 08.02.2014 by 11:00am.
- 4. The Commission also advised Spl. Secretary (Power), GoNCTD to inform the Commission about various actions that have been taken by the Govt. of Delhi on statutory advice given by the Commission from time to time on or before the next date of hearing.
