### **INTERIM ORDER**

(Date of Hearing: 22.05.2018) (Date of Order:11.06.2018)

1. The instant petition has been filed by Indian Wind Power Association (IWPA) for seeking directions for compliance of the Renewable Purchase Obligation (RPO) imposed upon the obligated entities in the state of Delhi.

2. The petition Nos. 30 of 2015, 31 of 2015 and 01 of 2018 filed by BRPL and BYPL are filed for waiver for deferment of RPO. The instant matter being contingent to the decision in these matters was tagged with the aforesaid petitions. However, the petition Nos. 30 of 2015, 31 of 2015 and 01 of 2018 are being decided separately, therefore the instant tagged matter 80 of 2015 is de-tagged.

3. Vide Interim Order dated 29.01.2018, the respondents were issued show cause notice to file reply, as to why a penalty u/s 142 of the Electricity Act, 2003 should not be imposed on them for violation of provisions of the DERC (Renewable Purchase Obligation and Renewable Energy Certificate Framework Implementation) Regulations, 2012.

4. The respondents have since filed replies to the show cause notice. Copies of the replies were also served upon the petitioner.

5. At the request of the Counsel for the petitioner two weeks time is granted to file rejoinder to the replies of show cause notice filed by the respondents, with an advance copy to the respondents.

6. The next date of hearing will be informed in due course.
