## ORDER

- 1. The Petitioner, NDPL filed the Petition No. 08/2009 in the matter of the Hon'ble Commission's directions made vide letter no. F.7(25)/DERC/2008-09/2322 dated 11.09.2008 relating to charging of Security Deposit Attributable to the change in ownership. The Petitioner through this Petition prayed the following:
  - a) Allow, admit the present Petition and pass an order withdrawing the impugned directions issued vide its letter no. F.7(25)/DERC/2008-09/2322 dated 11.09.2008 and

- b) Pass such other or further/order/s as this Hon'ble Tribunal may deem fit and proper in facts and circumstances of the case.
- 2. Ld. Counsel Sh. Krishnendu Datta, appearing for NDPL argued the matter. The Commission heard the Ld. Counsel Sh. Datta.
- 3. The Commission is in the process of amending/framing new Supply Code and Performance Standard Regulations and will hold a public hearing shortly before finalizing these Regulations. Therefore, the Commission is of the view that NDPL can raise these issues during public hearing in the presence of other Stakeholders/Consumers. The Petitioner agreed with this course of action. No further action is needed in this petition.
- 4. In the light of above discussion, the Commission disposed off this Petition while granting liberty to the NDPL to raise these issues during public hearing to be held shortly.
