INTERIM ORDER

(Date of Hearing 26.07.2016) (Date of Order: 05.08.2016)

1. The counsel for the petitioner submitted that the aforesaid petitions have been pending before the Commission since 2012 for determination of tariff including

approval of change in land use and PPA. In a recent judgment dated 20.07.2016 in Appeal No. 271 of 2013, the Hon'ble Appellate Tribunal for Electricity has given the following directions to the Commission:

"We direct the Delhi Commission to expedite the process of determination of tariff for Rithala plant and determine the tariff within four months from today and till then allow actual cost of generation incurred by the appellant towards procurement of power form Rithala station."

- The Counsel of the Petitioner further submitted that it has responded to all the queries raised by the Commission and to expedite the process of tariff determination it is also willing to sit with the officers of the Commission to solve any issues relating to tariff determination.
- 3. On a query of the Commission regarding the break up of the assets along with capital costs which can be further utilized in the distribution network of the Petitioner even after the decommissioning of the project, the Petitioner submitted that the only asset which can be used as part of the distribution network is the mains swithchyard costing approximately 5 Crore and rest all assets are part of the generating system and cannot be utilized for distribution network.
- 4. On the submission of the Petitioner the Commission directed the Engineering Division of the Commission to visit the plant jointly with the Petitioner and submit a report to the Commission on or before 15.08.2016 regarding the part of the plant which can be utilized for distribution business of the petitioner, along with cost bifurcation.
- 5. The decision on tariff determination will be taken on receipt of the report from the Engineering Division. The order is reserved.
- 6. Ordered accordingly.
