Counsel for Petitioner submitted that apart from this Petition they have also filed Petition No. 7/2010 regarding approval for usage of 6 acres of land located in the licensed area of the Petitioner to set up 108 MW Power Generation Plant at Rithala, Delhi & Petition No. 66/2011 regarding Petition Seeking determination of provisional Generation Tariff for 108 MW Rithala Combined Cycle Power Plant u/s 62 read with Part VII of the Electricity Act, 2003 and the DERC (Terms & Conditions for Determination of Generation Tariff) Regulations 2007: (a) In Open Cycle mode of Gas Turbine Units 1 and 2 of the Rithala Plant from COD i.e. 05.02.2011 till 31.03.2011 (b) In Open Cycle mode of Gas Turbine Units 1 and 2 of the Rithala Plant from 01.04.2011 till 03.09.2011 (c) In Combined Cycle mode from 04.09.2011 till 31.03.2012 where issues are inter-related.
