### **ORDER**

(Date of Hearing: 20.10.2011) (Date of Order: 24.10.2011)

 The Petitioner, NDPL, filed Petition No. 14/2010 for Refund of excess Transmission charges collected from the NDPL by DTL for wheeling of 62.5MW Power to the State of Haryana from I.P. Station of IPGCL.

- 2. The NDPL through this Petition sought the following:
  - a. Conduct an enquiry and investigation into the concerns raised by Petitioner; and/or
  - b. Examine the contentions of the Petitioner raised in the present petition and verify/determine the amount of excess transmission charges that have been unlawfully recovered by the Respondent No. 1 from the Petitioner in relation to supply of 62.5MW power from IP power to the State of Haryana, and direct the Respondent No. 1 to refund the same to the Petitioner along with interest @ 18% per annum from the date of payment of respective amounts till the date of refund.
- 3. The Commission heard Mr. Sakya Singh Choudhari, Ld. Counsel for NDPL at some length. The Commission noticed that DTL has not filed its reply. The DTL made a request for grant of 10 days time to file its reply. The Commission granted the liberty with a direction that DTL will file its reply within 10 days with an advance copy to the NDPL. On the request of the NDPL, Commission also granted 10 days time to NDPL to file its rejoinder, if any, from the date of the receipt of reply from the DTL.
- 4. The matter is listed for further hearing on **24.11.2011**
- 5. Ordered accordingly.
