## **INTERIM ORDER**

(Date of Hearing: 08.01.2013) (Date of Order: 07.02.2013)

- This petition has been filed by NDPL for approval of Terms and Conditions entered between NDPL-G and NDPL-D for procurement of entire Solar Energy generated from 60 KW Solar Project at DSIDC-II Grid, Narela, Delhi.
- 2. During the course of hearing, the Commission enquired from the Counsel of the Petitioner about the various subsidies / incentives available to such project, including capital subsidies, generation based incentives (GBI) for projects registered under Jawahar Lal Nehru National Solar Mission and availability of carbon credits from MNRE. The Commission noted that in its earlier order dated 09.07.2010, a general dispensation of allowing tariff in conformity with the CERC guidelines for renewable energy projects had been given subject to their registration and eligibility for GBI.
- 3. In response to the query of the Commission, the Counsel for the Petitioner informed that in this project no subsidy / incentive/CFA is available.

4. The Commission directed that since no financial assistance is available for this project, therefore, Petitioner can approach the State Nodal Agency for REC registration/accredition for obtaining REC, which shall be in the overall interest of the consumers of NCT of Delhi. This may be done with immediate effect.

5. The Commission also observed that in the case of such a project, a separate dispensation can be considered for energy fed into the generation till REC registration and accredition, which shall in any case be not later than 31.03.2013.

6. The Commission further directed that audited accounts be submitted for above Solar PV Project for which the tariff determination has been sought.

7. The Commission further directed to furnish details about the actual rate of interest on the monies borrowed by the Petitioner (loans & working capital) till date.

8. The Counsel for the Petitioner sought one month's time for filing the above information.

9. The Commission granted liberty to file the information on Affidavit within one month.

10. The matter is listed for hearing on 26.02.2013 in the office of the Commission at 3.00 P.M.

11. Ordered accordingly.
