1. In compliance of the Commission's direction DTL, filed a detailed reply with copy to BRPL, BYPL and TPDDL. The same is taken on record.
2. BRPL & BYPL filed its rejoinder/additional reply with an advance copy to DTL. The same is also taken on record.
3. Mr. Alok Shankar, Ld. Counsel for TPDDL made a request for grant of two more weeks' time to file a reply. The Commission considered the request of TPDDL and granted two weeks time to file a reply with an advance copy to DTL.
4. Ms. Swapna Sheshadri, Ld. Counsel for DTL submitted that the Central Commission in Suo-Motu Petition No. 09/2014 directed CEA to submit State wise report on availability of the transmission system. She has further submitted that CEA has forwarded its report regarding DTL to the Central Commission and she will place a copy of it before the Commission within a week.
5. Ms. Sheshadri sought two weeks time to file a reply. The Commission granted liberty to DTL to file a reply within two weeks with an advance copy to BRPL,, BYPL and TPDDL.
