ORDER

(Date of Hearing: 08.12.2011) (Date of Order: 09.12.2011)

1. Mr. Rakesh Kumar Yadav, Vice President (Legal/Commercial) DAMEPL submitted that Petitioner is a Special Purpose Vehicle (SPV) for implementation of Delhi Airport Metro Express Line Project. Their scope of work is to develop, Finance, Operate and Maintain the said project and collect the fares for a concession period of 30 years. The SPV comprises of

Reliance Infrastructure Limited (95%) and Construccioners Y Auxiliar De Ferrocarriles, S.A. (CAF), Spain (5%). The concession agreement was also executed between Delhi Metro Rail Corporation Limited and Delhi Airport Metro Express Line Project.

- 2. Mr. Yadav further submitted that the purpose for which the supply of Electricity required is identical to that of M/s DMRC. The aforesaid project is also a social sector project with a low financial rate of return and its viability is greatly impacted by the price of Electricity.
- 3. Mr. Yadav through this Petition sought the following:
 - I. To categorize the said Petitioner under the category of DMRC, Tariff.
 - II. Direct the Respondents to charge the Petitioner with the tariff as applicable to the DMRC for traction/operational requirements.
- 4. The Commission heard the Petitioner at some length and decided that the Petition be admitted for detailed hearing.
- The Commission further directs to issue notice to concerned parties alongwith DMRC for hearing on 19.01.2012
- 6. Ordered accordingly.
