INTERIM ORDER

- 1. The Commission heard the Ld. Counsel Mr. Sanjay Sen, Sr. Advocate for the Petitioner at length.
- 2. The Ld. Counsel Mr. Sen submitted that in compliance of its Solar Renewable Power Obligations it has initiated the process of procuring renewable power on a long term basis through tariff based Competitive Bidding process (CASE 1 RE). The Letter of Intent was issued to Reliance Green Power Private Limited as successful bidder for capacity of 30MW for contract A (levelised tariff 10.825), 8MW for contract B (levelised tariff 10.899) and 9MW for contract C (levelised tariff 10.976).
- 3. The Ld. Counsel for the Petitioner further submitted that the Commission may admit this petition and adopt the tariff determined through the transparent process of CASE 1 RE-Bidding procedure and also approve Power Purchase Agreement between the procurers (BRPL & BYPL) and Reliance Green Power Private Limited.

- 4. The Commission admits the petition. The tariff division to submit its report before the next date.
