### **INTERIM ORDER**

(Date of Hearing 08.12.2017) (Date of Order: 18.12.2017)

- 1) The petitioner has filed the instant petition under Section 86 (1)(b) and other provisions of the Electricity Act, 2003 for approval of bidding process, adoption of tariff of Municipal Waste to power plant and approval of draft PPA.
- 2) The hearing was attended by the petitioners and the representative/counsels for TPDDL (Respondent No. 1), BRPL (Respondent No. 2) and BYPL (Respondent No. 4). However, no appearance was made on behalf of MES (Respondent No. 3), NDMC (Respondent No. 5), DTL (Respondent No. 6) and SLDC (Respondent No. 7).
- 3) The counsel for the petitioner submitted that a copy of draft PPA has been filed alongwith the petition for approval of the Commission. It was further submitted that the draft PPA is on the line of PPAs already signed by the DISCOMs of Delhi in respect of MSWTE Project at Bawana of Delhi MSW Solutions Limited, which have already been approved by the Commission.
- 4) The Commission directed the parties to hold meetings so as to agree to the conditions of PPA and report to the Commission by the next date of hearing.
- 5) The matter is listed for hearing on 20.12.2017.
- 6) Ordered accordingly.
