INTERIM ORDER

(Date of Hearing: 20.10.2015) (Date of Order: 02.11.2015)

- M/s BRPL and BYPL has filed the instant IA seeking exemption of fee in resepect of the petition filed by them seeking adoption of tariff through transparent process of Case-1 RE Bidding and approval to sign the Power Purchase Agreement in accordance with Section 63 of the Electricity Act, 2003.
- Through the instant IA the Petitioner have sought exemption of fee on the plea that the Commission vide its order dated 25.09.2015 in Petition No. 54
 & 55 of 2013 filed by BRPL and BYPL had granted liberty to the petitioners to withdraw the aforesaid petitions (No. 54 & 55 of 2013) as that the

matter regarding the deviation from the draft standard bidding documents issued by the MNRE on the revised Request for proposed, would be dealt with separately.

- 3. The Counsel for the Petitioner submitted that apart from the aforesaid plea, the request for exemption of fee is supported by the following two grounds also;
 - that there is a cash crunch and adverse cash flow problem in the Petitioners' Companies and exemption of fee may provide a relief, and
 - (ii) the Commission has extended such type of relief to another DISCOM viz. TPDDL in a similar petition Numbered 58/2015.
- 4. The Commission directed the Law Division to examine the issue in light of the submissions made by the petitioners and adjourned the matter.
- 5. The next date of hearing will be informed in due course.
- 6. Ordered accordingly.
