ORDER

- 1. The Commission heard the Petition on admission.
- 2. The Petitioner has sought the review on the following issues:
 - (i) Truing up the financials for the years 2007-08 to 2010-11;
 - (ii) Implementation of the judgment dated 07.04.2011 of the Hon'ble Appellant Tribunal for Electricity.
 - (iii) Extension of the principles of Multiyear Tariff Control period FY 2007-08 to 2010-11 for the FY 2011-12 without appropriate adjustments;
 - (iv) Station Heat Rate of RPH Station determined at 3049.8 kCal/kWh by applying the margin of 5% instead of 6.5% for coal based stations as applied by the Central Commission.

- (v) Relaxation of Heat Rate in open cycle mode for GTPS in accordance with the relaxation provided by the Central Commission for the Assam Gas based Stations;
- (vi) Not allowing 2% excess heat rate for operating the GTPS on liquid fuel;
- (vii) The payment made to the pension trust in pursuance of the Sixth Pay Commission.
- (viii) O&M Escalation allowed at 4% whereas even the Central Commission has allowed a 5.72% escalation factor.
- 3. As far as issue no. 1 is concerned, the Petitioner's True-up Petition for the year 2007-08 to 2010-11 has already been admitted by the Commission in a separate Order dated 15.02.2012 alongwith the Petition for determination of generation tariff for MYT Control Period FY 2012-13 to 2014-15. Therefore, this Petition is admitted to examine the rest of the issues.
- 4. The matter is listed for further proceedings on 12th July, 2012.
- 5. Ordered accordingly.
